I. ROLL CALL

Supr. Marshall opened the meeting with roll call.

III. APPROVAL OF MINUTES

On a motion made by Councilman Wohlschlegel and seconded by Councilman Cowley, the December 12, 2017 Regular Town Board meeting minutes and the December 24, 2016 Year-End meeting minutes were ACCEPTED. Supr. Marshall informed the Town Board that through the advice of the EFPR Group, the Town's bank accounts have been reduced from 9 bank accounts down to 3 bank accounts. The is the logical thing to do; a master savings account, a master disbursement account and a payroll/trust & agency account. This will make the bookkeeping process quite a bit simpler.

VI. OLD BUSINESS:

Supr. Marshall noted that last month there was a resident who came to the Town Board and suggested that the Town of South Bristol should be responsible for looking into what could possibly be considered a criminal act done by the Bristol Harbor Sewer Corp. in previous years. Anything that has to do with regards to a sewer corporation is dictated by NYS Transportation Corporation Law, Article 10 and Article 10 has about 12 sections. Within those sections, it described the responsibility of the Town. As the law reads, the Town is supposed to review the bookkeeping of the sewer district corporation on two separate occasions; minimally every 5

years the Town is obligated to review the bookkeeping and secondly, when the sewer corp. comes to the Town Board for a rate increase. There is talk about a potential rate increase at Bristol Sewer Corp., but at this point and time we have no application or request.

Supr. Marshall continued, noting that it was suggested that he contact a State Police Investigator and the Town Attorney, which he did. It is the Town Attorney's opinion that the Town is to operate under the requirements of the NYS Transportation Corporation Law which basically limits our financial obligations to a fair and equitable rate is in place and that the corporation has the financial wherewithal to be in business. What we will be reviewing in April or May is the expansion of the sewer district. In addition, there is a possibility that there may be a rate increase at that point.

Supr. Marshall noted that both the Town Attorney's, Jeff Graff and also Mary Jo Korona, were asked for their opinion regarding the criminal activity. Both attorneys's stated that this is not something that is to be managed or handled by the Town itself; if there are people that feel there has been a wrong doing and some sort of loss taken as a result of this they should make the request. Today, our Town Attorney also spoke with the District Attorney, Michael Tantillo, and again it was his suggestion that unless the Town of South Bristol, in its review of books, comes up with some degree of certainty that some crime was committed, then that is about the only time they might want to step forward. Supr. Marshall said he didn't feel it was the position of this Town Board, that something absolutely and positively happened; we don't know that for a fact. It could very well be a legitimate accounting move; we don't know. If a group of people believe that they have been wronged, then it is incumbent upon them to move forward and request an investigation.

RESOLVED, that the Town Clerk be, and she hereby is, directed to post a copy of the proposed Local Law on the Town of South Bristol sign board and take any and all other necessary actions to properly bring the aforementioned Local Law before the Town Board of the Town of South Bristol for its consideration; and be it further

RESOLVED, that the Town Clerk be, and hereby is, authorized to provide all other notices as required by law for the adoption of this local law.
