Supr. Marshall opened the meeting with roll call.

### **PUBLIC HEARING:**

### TOWN OF SOUTH BRISTOL NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE, that a public hearing will be held by the Town Board of the Town of South Bristol on the 13<sup>th</sup> day of April, 2020, at 7:00 p.m., at the South Bristol Town Hall, 6500 Gannett Hill Road - West, South Bristol, New York, regarding the adoption of a Local Law, which would make the exemptions under subsection 8(a) of §487 of the New York State Real Property Tax Law with respect to any farm waste energy system, micro-hydroelectric energy system, fuel cell electric generating system, micro-combined heat and power generating equipment system, electric energy storage equipment and electric energy storage system, or fuel-flexible linear generator electric generating system constructed subsequent to the effective date of this local law inapplicable within the Town of South Bristol to town taxes.

Any resident of the Town of South Bristol shall be entitled to be heard upon said proposed Local Law at such public hearing. Copies of said proposed Local Law are available for review at the Town of South Bristol Town Hall, 6500 Gannett Hill Road - West, South Bristol, New York 14532.

### V. COMMITTEE REPORTS: HIGHWAY

Councilman Cowley read a summary he received from Supt. Wight.

The highway report for this last month is as follows: Currently operating the Dept. at 50 % staff due to Covid 19 guidelines. We are busy painting plows / wings and getting equipment ready for the summer construction season. We are also busy with cleaning out the building that we are still hopefully going to demolish to make way for the new structure. We have erected the "hoop barn" on the south side of the salt barn. Now we need to build end walls and put the canvas cover on it. And, as always, this time of year, we are patching potholes and cleaning up tree branches roadside. We have also been out plowing at the end of March and the first week in April.

Councilman Wohlschlegel asked if we are moving ahead with the Barn, have they started dismantling yet??

Supt. Wight said he is waiting to hear whether the Barn project will happen because of everything going on.

Supr. Marshall said there are a couple of things to take into consideration; 1. Asbestos Abatement that needs to be done. No demolition work can be done until that is taken care of. We are receiving bids for that and it needs to be done. The second item is, before we start tearing down buildings, we have to decide if we are going forward with this project given the current situation we are facing.

### FINANCE REPORT – PERMISSIVE REFERENDUM/ESTOPPEL PERIOD

Supr. Marshall noted that as of April 15<sup>th</sup>, the Permissive Referendum period will expire and at that point a 20-day Estoppel period before any type of bonding can be done or accept a bid or signal to start proceeding.

Supr. Marshall said we have 20 days to decide if the project is going forward. The asbestos is a small amount of flooring, nothing major. One of the things that is deeply concerning is the sales tax revenue dropping by 20%; and on the other hand, we will not get a better price for interest rates on bonding, or contract pricing, which all needs more discussion. Supr. Marshall noted that he did discuss this with the Bob Fox of EFPR who agreed that the project should move forward but was nervous about the sales tax revenue; Mary Gates, the Director of Finance for Ontario County, said that we should proceed with the idea that we have to keep moving forward anyways. The bottom line is we really wouldn't have any affect on our tax rate until 2021. We do have reserve monies to help defray the some of the costs initially if

we need to. We also have another reserve fund available for paying interest on the bond anticipation note.

Supt. Wight said that in an effort to see this project go forward, the Highway Department can make some concessions in equipment this year. We have the Loader to pay for, and shut down the spending line, \$126,000.00 and can do the roadwork next year.

Supr. Marshall said that would be helpful and might only defray the costs of what we might lose in revenue for our sales tax. The next sales tax check the Town receives will not be affected by the shut-down; the first quarter of 2020, January, February and March. After this month, we really do not know where we may be headed.

Councilwoman Goodwin asked when the 2<sup>nd</sup> quarter sales tax check is received?

Supr. Marshall said that those funds are received in September; it is the summer months that are going to hurt.

Supr. Marshall said he is not ready to put the Highway Barn on hold and will be doing more research; talking to more people that have more insight and expertise. We can't dismiss the fact that the Town needs the building; the price is as good as it is going to get and the interest rates will be good. We will probably be having a Special meeting in the next week or so for this decision.

SECTION 1. The title of Article IV of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby amended to read as follows:

"Nonapplicability of Exemptions from Taxation for Certain Energy Systems" SECTION 2: Section 153-11 of Article IV of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby repealed and a new section 153-11 is hereby inserted in its place to read as follows:

This article is enacted pursuant to § 487 of the New York State Real Property Tax Law, as most recently amended by Chapter 325 of the laws of 2018.

SECTION 2. Section 153-12 of Article IV of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby repealed and a new section 153-12 is hereby inserted in its place to read as follows:

Pursuant to subsection 8(a) of § 487 of the New York State Real Property Tax Law, the Town of South Bristol, by this article, provides that no exemption under §487 of the New York State Real Property Tax Law shall be applicable within its jurisdiction to town taxes with respect to any solar or wind energy system, farm waste energy system, micro-hydroelectric energy system, fuel cell electric generating system, micro-combined heat and power generating equipment system, electric energy storage equipment and electric energy storage system, or fuel-flexible linear generator electric generating system constructed subsequent to the effective date of local law amending this section.

SECTION 3. This local law shall take effect immediately upon filing with the Secretary of State
