APPROVAL OF VOUCHERS

On a motion made by Councilwoman Goodwin and seconded by Councilman Cowley, Abstract No. 13, totaling \$13,583.06 was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

MEETING ROOM IMPROVEMENTS

Supr. Marshall said that the Board needs to approve the painting, the acoustical panels and audio/visual equipment. A second quote from Ronco has been requested and we are still waiting on that.

Supr. Marshall said he would like a motion that would encumber the funds of the 2020 budget for the meeting room improvements. The acoustic panels need to be taken off the table.

Councilman Strickland agreed, and did a review of the system in the R-Options quote and this system is at least 10x the system we have currently. The quote does mention that if we do not go with the acoustic panels we should go with a different digital processor. The processor he has in the original quote already has some of the most advanced feedback suppression on the market. The acoustic panels for a quote of \$6,500 is overkill.

Councilman Cowley asked, you are suggesting that we don't need the acoustic panels and would like to move forward with this system and go from there if we really need to add the panels.

Councilman Strickland agreed, it's all top of the line.

On a motion made by Councilman Wohlschlegel and seconded by Councilman Strickland, the acoustical panel quote was rejected was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Cowley and Strickland.

Supr. Marshall continued, the Board will wait for the Ronco quote for comparison, and we can still encumber the funds from the 2020 budget.

On a motion made by Councilwoman Goodwin and seconded by Councilman Cowley, the funds needed for the audio/video system for \$12,663.34 was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Cowley and Strickland.

Supr. Marshall continued with the Meeting Room improvements and mentioned that the room needs to be painted. The Town received 2 quotes, Pride & Trust Painting and Brian Hermann from Naples.

On a motion made by Councilman Strickland and seconded by Councilwoman Goodwin, the Pride & Trust Painting quote was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Cowley and Strickland.
