# V. COMMITTEE REPORTS: HIGHWAY

Councilman Strickland read the Highway Report:

Following is a brief summary of events at the Highway Department in the last month.

- Two winter storms blew thru, a lot of plowing was done, and a lot of material expended. (Large salt bill)
- 2 orders of salt have come in. 1000 tons each. Hopefully enough material to get us through the balance of winter.
- Working on fixing/ maintaining summer construction equipment to have ready for the season.
- New Kubota tractor to replace our existing New Holland tractor has arrived.
- The small New Holland tractor served us well for over fifteen years.

I will be looking to have the New Holland tractor declared surplus, so we can send it to auction.

I also have the annual Article 284 (Agreement to spend Highway Funds) drawn up and 2 copies will be available for signatures this evening.

Jim Wight – Town of South Bristol Highway Superintendent

Supr. Marshall read the Agreement to spend Highway Funds and noted that General Repairs is \$325,000, Permanent Improvements for Seneca Point Road, \$175,000, South Hill Road, \$75,000 and Lower Egypt Road \$15,000.

Supr. Marshall mentioned that the ARPA Funding is available for culverts; the Town has received \$82,000 and will receive another check this year for the same amount. Something we can discuss.

Supt. Wight said he is interested in this; there is a bridge on Lower Egypt he would like to replace with a culvert. This would be an arch culvert that can withstand 1000 lbs.

#### **RESOLUTION NO. 28-2022**

**WHEREAS**, the Town Board of the Town of South Bristol is the governing body of the special districts and/or fire protection districts set forth in the Schedule attached hereto and made a part hereof; and

WHEREAS, it is the intent of this resolution to override the limit on the amount of real property taxes that may be levied by the Town of South Bristol, on behalf of the aforesaid special districts and/or fire protection districts, pursuant to General Municipal Law §3-c, and to allow the Town of South Bristol, on behalf of the aforesaid special districts and/or fire protection districts, to adopt a budget for the fiscal year 2023 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c; and

**WHEREAS**, this resolution is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the tax levy limit for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

**NOW, THEREFORE**, **BE IT RESOLVED**, that the Town Board of the Town of South Bristol, County of Ontario, is hereby authorized to adopt a budget for the fiscal year 2023 on behalf of the special districts and/or fire protection districts set forth in the Schedule attached hereto and made a part hereof that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

A local law to override the tax levy limit established in General Municipal Law §3-c

Section 1: Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of South Bristol, County of Ontario pursuant to General Municipal Law §3-c, and to allow the Town of South Bristol to adopt a town budget for (a) town purposes (b) fire protection districts and (c) any other special or improvement district governed by the town board for the fiscal year 2023 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2: Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the town board.

Section 3: Tax Levy Limit Override

The Town Board of the Town of South Bristol, County of Ontario, is hereby authorized to adopt a budget for the fiscal year 2023 that requires a real property tax levy in excess of the limit specified in General Municipal Law §3-c.

Section 4: Severability

If any clause, sentence, paragraph, section, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, or part of this local law or in its application to the person, individual, firm or corporation, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

Section 5: Effective Date
