## I. ROLL CALL

Supr. Marshall opened the meeting with roll call.

### III. APPROVAL OF MINUTES

On a motion made by Councilman Wohlschlegel and seconded by Councilman Cowley, the minutes of the Regular Town Board Meeting, April 11, 2022, were ACCEPTED. Voting AYE: 3. Voting NAY: 0. Voting AYE: Marshall, Cowley and Wohlschlegel. One Abstain: Goodwin.

#### IV. PRIVILEGE OF THE FLOOR

Tom Hawks of Stemple Hill Road, handed out information to the Town Board for the 2022 Naples Grape Festival. Mr. Hawks said he is the President of the Naples Grape & Arts Festival, LLC and is excited to share changes to the festival; we did research last year and we found that the Festival really needed a change. It needed to become more community oriented, and we need to give back more than just giving to the Naples Rotary and Historical Society which is a wonderful thing, but the thing is we've realized that most of the community was not being served. The Naples Grape Festival 2022 basically three opportunities for engagement. We are looking to do community events covering 2 weekends. The Grape Festival started in 1874 and started as an agricultural fair for the community to come together to celebrate the harvest of grapes and to really share community. Back in 1961, Bob and Bill Vierhile resurrected the Grape Festival which was quite the affair beginning with a 3-hour parade, with street dances, carnival. That is just an idea of what you are seeing here; we have found that people want the nostalgic back and with Covid just ending it is a perfect time. We, Naples, which includes South Bristol, have an opportunity to really show this region what it is like to live in small town, USA. For the Events, the Fireworks Extravaganza, in front of Hazlitt's, which will coincide with the

Naples Central School Homecoming weekend. In particular, with the loss of Phil Hall, there is a lot of need for the kids who were on his team to be able to heal. We are hoping that this will give them an opportunity to do that. On Saturday, the parade at 10am, including all towns in the regions and would love if South Bristol Highway could be part of the parade. The Street Dance is during the Homecoming Dance so the kids can go off and the parents can have fun too. There is a Home Winemakers Competition and a Chili Cook-off. The Kick-Off Event is the Boots & Blue Jeans Gala at the Parish Hill Barn with Grove Boys serving and a band for dancing. Then the 24<sup>th</sup> & 24<sup>th</sup> of September is the historic Naples Grape Festival and looking at having a family park, in front of the school. There will be a place for tables and chairs set out and there will be activities for kids all the way around. A wellness center has also been planned for the festival. We will also be selling grapes at the festival although it might be too early. Mr. Hawks continued and said he is here tonight promoting the events and the festival, and a fundraising campaign, \$2 for 22, asking residents each for \$2.00. Mr. Hawks said that he would like the Grape Festival to be one everyone looks forward to, not to leave town. Each year, we save money to support the next year to get started and this year, we have nothing. What we are trying to do is create a fund that will fund this year's and then next year's Community Events. They will be for the Community. When I started speaking with people about the \$2 for 22, the Organizations started saying, can't we give? We have several municipalities and organizations that are donating \$100 up to \$500.00 and hoping that South Bristol will support the Grape Festival.

Supr. Marshall and the Board agreed to \$500 contribution to the Naples Grape Festival. Mr. Hawks thanked the Board for their time.

Supr. Marshall noted that Clerk Voss has submitted an invoice for vinyl and padded 50 stackable chairs for \$1,324 from BizChair.com. We would keep the folding chairs for other events.

On a motion made by Councilman Wohlschlegel and seconded by Councilwoman Goodwin, the invoice for 50 chairs costing \$1,324.00 was ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Goodwin and Wohlschlegel.

# V. COMMITTEE REPORTS: HIGHWAY

Councilman Cowley read the Highway Report: Following is a brief summary of events at the Town Highway Dept. Summer construction is under way. Town properties are being mowed. Tree trimming took place earlier on several roads (to be continued). Stone is all hauled for Chip Seal. Drainage and ditching are being completed on South Hill. 2500 tons of 1½ minus crushed gravel is stockpiled for mix paving on South Hill. We are half across Seneca Pt. Rd. between the bottom of Bopple Hill and Hicks Rd. paving with hot top. The County crew is paving for us. Roadside mowing to commence soon.

Supt. Wight said that it is time to think about replacing the dumpsters at the Transfer Station. We purchased a co-mingle container 3 years ago which is working fine. A new compactor box was purchased 2 years ago and does not need to be replaced. The other dumpsters, 20-yard, were replaced 9 years ago for \$6,000 each.

On a motion made by Councilman Cowley and seconded by Councilwoman Goodwin, the Highway Report was ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Goodwin and Wohlschlegel.

Supr. Marshall said that the first Bond payment is due, \$35,353.00 and will be wired directly.

### VI. OLD BUSINESS: HAYS PROPERTY

Supr. Marshall said that they have been working on the clean-up for little over a week now. The barn is gone, there have been a few issues, Mr. Hays demanded that the contractor leave; the Sheriff was shown the Court Order and we were able to continue the clean-up. The Hays family has had every opportunity extended to them to protect anything that needed to be protected.

#### **BROADBAND - STATUS & EMPIRE ACCESS**

Supr. Marshall said he has been speaking with Empire Access and Charter Communications/Spectrum on the \$1.1 million proposal that Charter provided us. They would be willing to pay \$240,000 towards the build-out. The other thing is that Charter gave the Town an amount to cover Stid Hill Road; Stid Hill Road is totally covered by Empire Access, they have a tower at the top and everyone has fiber optic broadband. Supr. Marshall spoke with Empire Access about covering Gannett Hill Road, from Powell Hill Road to the park entrance and come down the hill to Route 64. Empire Access gave an estimate cost for Gannett Hill around \$120,000.00; Charter wanted over \$250,000.00. It is troubling that Empire installed fiber optic on Stid Hill Road, and it didn't cost the town anything; now they want us to spend \$120,000.00 for Gannett Hill Road. There is no franchise tax agreement with Empire Access.

#### KICK OFF MEETING WITH MRB FOR CODE REVIEW

Supr. Marshall informed the Board there is a kickoff meeting with MRB Group is next Tuesday at Noon. A steering committee has been created between the two chairs, Tom Burgie from ZBA and Matt Sousa from the Planning Board, CEO Martin and Deputy CEO Pierce and Diane Graham, Planning and Zoning Admin.

#### LOCAL LAW - RV'S & TWO RESIDENCES ON ONE LOT

Supr. Marshall said that the local law that we held the Public Hearing on earlier is before the Board for approval. Supr. Marshall noted that SEQR was taken care of at a previous meeting.

Councilman Wohlschlegel agreed. The determination is that there is no environmental concerns.

Supr. Marshall said he would entertain a motion to accept the resolution authorizing adoption of the local law.

On a motion made by Councilman Wohlschlegel and seconded by Councilwoman Goodwin, Resolution No. 31-2022 was ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Goodwin and Wohlschlegel.

hear all interested parties on a proposed Local Law entitled, "A Local Law Amending the Zoning Law of the Town of South Bristol to Amend Regulations Pertaining to Additional Residential Structures on the Same Lot and to the Storage and Use of Recreational Vehicles" and

**WHEREAS**, notice of said public hearing was duly advertised in the official newspaper of the Town of South Bristol, on May 3, 2022 and other notices required to be given by law were properly served, posted or given; and

**WHEREAS**, said public hearing was duly held on May 10, 2022, at 7:00 p.m. at the South Bristol Town Hall, 6500 Gannett Hill Road - West, Town of South Bristol, New York, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Local Law, or any part thereof; and

**WHEREAS**, pursuant to part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law it has been determined by the Town Board that adoption of said Local Law would not have a significant effect upon the environment and could be processed by other applicable governmental agencies without further regard to SEQR; and

**WHEREAS**, the Town Board of the Town of South Bristol, after due deliberation, finds it in the best interest of the Town of South Bristol to adopt said Local Law.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board of the Town of South Bristol hereby adopts said Local Law No. 4 of 2022, entitled "A Local Law Amending the Zoning Law of the Town of South Bristol to Amend Regulations Pertaining to Additional Residential Structures on the Same Lot and to the Storage and Use of Recreational Vehicles", a copy of which is attached hereto and made a part of this resolution, and be it further

A Local Law Amending the Zoning Law of the Town of South Bristol to Amend Regulations Pertaining to Additional Residential Structures on the Same Lot and to the **Storage and Use of Recreational Vehicles.**

- Section 1. Paragraph C. of Section 170-38 (Additional residential structures on same lot) of Article V (Special Use Requirements) of the Zoning Law of the Town of South Bristol is hereby repealed and a new Paragraph C. is hereby inserted in its place to read as follows:
- C. All such structures shall have the same postal address. When entering the property, the first structure shall be numbered and lettered "A" and the second numbered and lettered "B".
- Section 2. Section 170-64 (Storage and use of recreational vehicles) of Article VI (Supplementary District Regulations) of the Zoning Law of the Town of South Bristol is hereby amended as follows:
- 1. The opening paragraph of Paragraph A. is hereby repealed and new opening paragraph is hereby inserted in its place to read as follows:
- . Storage: Not more than two recreational vehicles owned by the owners of the lot on which such owners reside or a member of such owners' family also residing thereon may be stored upon the lot, provided that:
- 2. The opening paragraph of Paragraph B. is hereby repealed and new opening paragraph is hereby inserted in its place to read as follows:
- B. Use: Guests of residents of the Town may have located upon the lot on which such residents reside a recreational vehicle as long as:
- 3. A new Paragraph C. is hereby added to read as follows:
- C. Use: Owners of a vacant lot located in the Town South Bristol may occupy and use a maximum of one (1) recreational vehicle on their vacant lot provided that:

The recreational vehicle is owned solely by one or more of the owners of the vacant lot; and The length of stay is no longer than 160 days; and

The recreational vehicle has been provided with water supply, electrical services and an adequate self-contained sewage disposal system; and

The recreational vehicle is not located closer than 15 feet to any building on a neighboring lot and no closer than 10 feet to the side or rear lot line.

Section 3. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause,

1. (Final adoption by local legislative body only.),

sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 4. This local law shall take effect immediately upon filing with the Secretary of State.

#### TOWN CLERK/TAX COLLECTION

Supr. Marshall read the Town Clerk's Report.

On a motion made by Councilman Cowley and seconded by Councilwoman Goodwin the April 2022 Town Clerk's Report and ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Wohlschlegel and Goodwin.

### IX. ACCOUNTING: SUPERVISOR'S REPORT

Supr. Marshall read the Supervisor's Report, with a balance of \$3,605,700.42 in the bank. The \$383,000.00 sales tax revenue has been deposited on top of that balance. The expenditures through April should equal 33% and under the A fund we are at 28% and the DA fund at 25.3%. Again we are staying well below the budget.

On a motion made by Councilman Wohlschlegel and seconded by Councilwoman Goodwin, the Supervisor's Report for April 2022 was ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Wohlschlegel and Goodwin.

#### APPROVAL OF VOUCHERS

On a motion made by Councilwoman Goodwin and seconded by Councilman Cowley, the Abstract, totaling \$58,878.34 was ACCEPTED. Voting AYE: 4. Voting NAY: 0. Voting AYE: Marshall, Cowley, Wohlschlegel and Goodwin.

#### PRIVILEGE OF THE FLOOR

Joe Kohler of Bristol Harbor, on the record, asked if he was correct in understanding that Assemblyman Gallagher has been replaced by redistricting?

Supr. Marshall said it was correct.

Mr. Kohler said that the meeting with Assemblyman Gallagher and his aide to the meeting was very helpful and that consider inviting the new Assemblywoman in to the next Town Board meeting.

Supr. Marshall said that Assemblywoman Burns, who is the replacement from Avon, has all ready been in twice now and she will be as good or better than Assemblyman Gallagher given that she has got seniority by 10 to 12 years; she is a great connection and will be very good. A bigger win for us is having Pam Helming as our Senator as opposed to the woman that was out of Rochester.

Mr. Kohler said excellent, has the Senator or the Assemblywoman been to a Town Board meeting yet?

Supr. Marshall, not to attend a Board meeting but technically these representatives will not be ours until the end of the year. All these representatives have to run in November too.

Mr. Kohler said he would like to formally mention that not only Assemblyman Jeff Gallagher, but his aide proved to be very useful and helpful to the people at Bristol Harbor Village with very real follow-up with Gov. Kathy Hochul's office and wanted to say Thank you.

Serge Weiss of Bopple Hill Road, asked about the Broadband that was presented earlier, right now we have DSL and it works fairly well and just wondering since there are a number of players that seem to be active in the South Bristol area with Broadband, what do you recommend to your constituents to reach out to find out if there is a possibility of getting Broadband?

Supr. Marshall asked where he is located.

Mr. Weiss answered, Blackberry Drive off of Bopple Hill Road.

Supr. Marshall said at the moment, there would be something coming off of Route 21 and at the moment that is Spectrum. Empire Access is all fiber optic and it is also the location of your property. The first 300 feet are included in the Empire Access broadband. Your property location might be covered by Spectrum at the moment.

Mr. Weiss also mentioned Verizon having internet access.
