Supr. Marshall opened the meeting with roll call.

#### III. APPROVAL OF MINUTES

#### IV. PRIVILEGE OF THE FLOOR

Joe Kohler of Bristol Harbour, thanked the Board and members, I rise to thank the Town of South Bristol, the Highway Department for that push on a portion of Seneca Point Road that is paved from Hicks Road to the bottom of Bopple Hill. I respectfully request as requested in the December meeting, can we get the rest of Seneca Point Road paved, from the golf course down to Hicks Road?

Supt. Wight agreed, we are working on that Mr. Kohler.

Supr. Marshall informed the Board that they had a  $2^{nd}$  meeting with MRB Group in which we are having a very thorough review of the Town Code; working very diligently to correct and improve the Code. That is what is being worked on; minutes have been completed from the meeting and the next meeting is on July  $26^{th}$ .

Supr. Marshall said he met with the Cheshire Fire Department, to discuss the 2023 Fire Contract and what they will be billing the Town for services.

(7:06pm Jim Strickland arrives)

Councilman Cowley said the 5 people that showed up for the Cheshire Fire Department were very professional and very proactive, they want to fix it before it breaks type thing and wanted to set up communication with the Town and very impressed with their presence and what they were thinking about doing and having a 10-year plan.

Supr. Marshall reported that the Traffic Report from the Sheriff's Office this month and asked them to please patrol Seneca Point Road. So far on this report they didn't; they have one citation on Route 21 and 3 citations on Route 64.

Supr. Marshall informed the Board that the Contract with the Teamsters Union is coming up and negotiations will begin soon.

Supr. Marshall said he met with the Town staff on June 28<sup>th</sup> and to discuss things outside the box and the needs to the Town Hall for the upcoming Budget Season.

Supr. Marshall asked Councilman Strickland for an update on the Town Hall foyer. Councilman Strickland said he is still waiting for the plans after being told they were nearly done and has called and left a message to get back to him.

### V. COMMITTEE REPORTS: HIGHWAY

Councilman Cowley read the Highway Report: Following is a brief summary of activities at the Highway Department in the last month.

- Roadside mowing continues.
- Backside of the overlook was recently mowed.
- Roads that were oiled and stoned being swept and prepped for new centerlines and fog lines.
- Picnic tables got a coat of stain.
- Town properties being moved (less frequently due to the weather).
- Drainage and patching on South Hill complete, ready for mix paving.
- Spent time at Wilder property grading and tuning up the driveway that goes back over the new pipe.
- Grass seed is left to do and install a guard rail over the culvert.

Supt. Wight said the trucks are still on order, the F-600 was ordered May 2021 and the F-350 was ordered in August or September 2021.

#### VI. OLD BUSINESS: HAYS PROPERTY – UPDATE

Supr. Marshall said that the Town received a Court Order from the Court that will allow the Town to charge Mr. Hays the full amount for the work that was done to clean-up his property.

#### <u>VII. NEW BUSINESS</u> APPOINTMENTS TO PLANNING BOARD

Supr. Marshall said that there are 2 positions on the Planning Board that need to be filled. We have one individual who is prepared to be appointed this evening and spoke with the Planning Board Chair, Matt Sousa, and he agreed. Supr. Marshall said that Mr. McIntyre lives on Route 64 opposite Bristol Mountain, is a retired dentist. The McIntyre family have owned that property for many, many years. Mr. McIntyre's father bought the property in the 1960's or earlier.

## A LOCAL LAW AUTHORIZING THE TOWN BOARD AND THE OTHER PUBLIC BODIES OF THE TOWN TO USE VIDEOCONFERENCING TECHNOLOGY TO PARTICIPATE IN PUBLIC MEETINGS

Section 1. Legislative Intent

It is the intent of this local law to give the town board and the town's other public bodies, as that term is defined in Public Officers Law § 102, the authority to participate in meetings via videoconference in a manner consistent with the town's videoconferencing policy and the authority granted in Public Officers Law §103-a.

Section 2. Authority

This local law is adopted pursuant to Public Officers Law § 103-a which expressly authorizes the town board to adopt a local law giving the town board and the town's other public bodies the authority to participate in meetings via videoconference from locations not accessible to the public so long as a quorum of the board/body participates from locations where the public may be physically present and other conditions, as may be set by resolution of the Town Board, are met.

Section 3. Supersession of New York State Town Law Section 62

Paragraph 2 of Section 62 of New York State Town Law requires, in part, that "All meetings of the town board shall be held within the town". To the extent that this local law permits members of the Town Board to participate in meetings of the Town Board via videoconference, this local law shall supersede this requirement of Town Law Section 62 in that those Town Board members permitted by this local law to participate in meetings of the Town Board via videoconference are permitted to so participate from locations that are not within the town.

Section 4. Videoconferencing for Public Meetings

In extraordinary circumstances, which include, but are not limited to, disability, illness, caregiving responsibilities, or any other significant or unexpected factor or event that precludes physical attendance, the Town Board of the Town of South Bristol hereby authorizes members of the town board and all members of the town's other public bodies to participate in meetings using videoconferencing technology in a manner consistent with Public Officers Law § 103-a and the town's videoconferencing policy, which shall be adopted by resolution of the town board and conspicuously posted on the Town website, with such members participating in meetings via videoconference being permitted to participate via videoconference from locations not accessible

to the public so long as a quorum of the board/body participates from locations where the public may be physically present.

Section 5: Severability

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 6: Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

#### LOCAL LAW – SPECIAL EVENTS

Supr. Marshall introduced the proposed Local Law and noted that the members of the Board have a copy of the proposed law for their review. It is a local law regarding Special Events and this is regards to any one that wants to build a an Event Barn or something to that effect. There needs to be a certain degree of review; there are requirements. The local law being considered basically applies to the "NC" Districts only, Neighborhood Commercial zoning, located on State Route 64 across from Bristol Mountain. People have asked why this doesn't include the whole town, and LR, Lake Residential, R-1, one-acre, R-3 and R-5, probably wouldn't accommodate 300 people. When we have the Public Hearing, that discussion will come up. If 25-50 people are coming to your house because your child graduated from High School, that is not what we are talking about here. It is large-scale events with event barns, things of that nature.

#### RESOLUTION – ALLOWING FOR CHANGING TO ONE JUSTICE

Supr. Marshall was notified by one of the Town Justices that they are moving out of state in October. We had talked about this in the past, does the Town truly need to have 2 judges. Both of the Town Justices say, probably not. It would be a savings if we reduced to one judge of \$9,000 for salary. This action requires a Resolution basically allowing the change to one Judge for the Town. The Board has a copy of the Resolution. This Resolution is also a Permissive Referendum that is required. Once the Resolution is passed, it needs to be published and posted that we are proposing the change from two justices to one. On a Permissive Referendum the public has 30 days to submit a petition of 25 names that would trigger an election to make this decision. Another resolution could be proposed that would take this directly to the election process which would add a proposition on the ballot, asking residents whether they agree, yes or no. We could do that or, the Permissive Referendum, we wait the 30 days. The deadline to add something to the ballot for the Board of Elections is August 8 and the 30-day notice expires August 14<sup>th</sup>.

RESOLVED, that this Resolution shall be subject to Permissive Referendum as provided by New York State Town Law Article 7, Section 90 through Section 94; and be it further

RESOLVED, the Town Clerk is hereby authorized to and directed to publish notice of this Resolution in the official newspaper of the Town within ten (10) days, and also within ten (10) days post on the signboard of the Town; and be it further

RESOLVED, that this Resolution shall take affect on the thirtieth day or upon such resolution having been approved by an affirmative vote of a majority of qualified electors of such town, if a valid petition be filed within the statutory authorized time period forcing such question on the ballot at a general or special town election. The resolution as stated above is hereby adopted by a majority vote of the Town of South Bristol Town Board at an official meeting held on the day of July 11, 2022.

Supr. Marshall read the Executive Summary of the Supervisor's Report, as of June 30<sup>th</sup>, this is exactly 6 months' worth of Town business and so far there are only a few accounts that are out of line as it pertains to next year's budget. Total receipts for June \$162,224.79, the biggest part of that is the \$80,908.00 in Mortgage tax and \$76,279.00 paid for the removal of Snow from Ontario County. The mortgage tax revenue is received twice a year, and the first payment in February was \$80,908.00; the total revenue budgeted for the Mortgage Tax line was \$80,000.00 so we had already met that earlier in the year.

Our year-to-date expenses are \$502,000.00 which is about 37.56% of the annual budget for the A fund. At this point we should be at 50%; the Highway budget year-to-date expenses are \$657,902.00, 39.75% of the yearly budget.
