I. ROLL CALL

Supr. Marshall opened the meeting with roll call.

II. APPROVAL OF MINUTES

On a motion made by Councilman Strickland and seconded by Councilman Wohlschlegel, the minutes of the January 9, 2023 Organizational Meeting and the January 9, 2023 Regular Town Board meeting were ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

V. COMMITTEE REPORTS: HIGHWAY

Councilman Cowley read the Highway report:

Following is a brief summary of events at the Town Highway Dept. in the last month.

- Working on cutting back brush roadside (Gannett Hill currently)
- Replacing road signage around Town that does not meet current DOT reflectivity standards.
- 500 tons of salt delivered.
- Plowing and ice control.
- In the process of getting quotes for several pieces of equipment.
- Repairing and painting summer equipment as needed.

On a motion made by Councilman Cowley and seconded by Councilwoman Goodwin the Highway Report was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

Supr. Marshall said the meeting is being held one week early because we would not have had a quorum for February 13th and that is the purpose of meeting one week early.

FINANCE

Supr. Marshall said that the 4th Quarter 2022 sales tax, up 5.88% from same quarter last year, \$427,696.00.

Supr. Marshall said he is working with Bookkeeper Dunn trying to determine a valid number for what we consider to be Unappropriated Fund Balance. It is a significant number, almost \$1 million and we need to probably have a discussion with our bookkeeping people as to how we got there. It seems almost incredible. We are going to have to do something about that money, the Comptroller frowns on that. We will be discussing setting up reserves, obviously the big one is a reserve to help pay for the new highway barn. But, we are not allowed to pay that off for 8 years.

Councilwoman Goodwin agreed.

Councilman Wohlschlegel asked about the entrance and where that stands?

Supr. Marshall said we have plenty of places we can talk about, we have a reserve now for \$154,000 that is left over from the new highway barn. Supr. Marshall said he needs to sit down with an accountant and a lawyer as to how to best handle that, you don't just create a reserve, in come cases you need a permissive referendum. Supr. Marshall said he will create a list of where we could put some of this money and how we could best use it.

Councilwoman Goodwin noted that there was a meeting with the employees to discuss projects, etc.

Supr. Marshall agreed, there are things we are working on, awfully slow, but we are working on it, getting some things changed. Waiting to hear back from the contractors for entryway. The transfer station is in need of work, the paving of the highway lot, there are places where the money can be used appropriately, we just make sure we do it the right way. Doing something with the existing highway building so that it matches the new building. I will meet with Bob Fox and get some good ideas.

Supr. Marshall continues, the Town's Fund Balance Policy was established in 2015 and nothing less than 15% and no more than 25% of your annual budget. The majority of municipalities follow the same guidelines and we are way over that right now. Nearly 100% of the budget.

Supr. Marshall said the Special Events Local Law will be part of the local law of the new zoning code.

LOCAL LAW TO OVERRIDE THE 2% TAX CAP REQUIRED BY NEW YORK STATE FOR THE TOWN AND FIRE DISTRICTS.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of South Bristol hereby adopts said Local Law No. 1 of 2023, entitled, "A local law to override the tax levy limit established in General Municipal Law §3-c", a copy of which is attached hereto and made a part of this resolution, and be it further

RESOLVED, that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of South Bristol, and to give due notice of the adoption of said local law to the Secretary of State of New York.

County City Town of South Bristol Village Local Law No. 1 of the year 2023 A local law to override the tax levy limit established in General Municipal Law §3-c (Insert Title) be it enacted by the Town Board (Name of Legislative Body) County City Town of South Bristol as follows: Village Section 1: Legislative Intent It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of South Bristol, County of Ontario pursuant to General Municipal Law §3-c, and to allow the Town of South Bristol to adopt a town budget for (a) town purposes (b) fire protection districts and (c) any other special or improvement district governed by the town board for the fiscal year 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c. Authority Section 2: This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the town board. Tax Levy Limit Override Section 3: The Town Board of the Town of South Bristol, County of Ontario, is hereby authorized to adopt a budget for the fiscal year 2024 that requires a real property tax levy in excess of the limit specified in General Municipal Law §3-c. Severability Section 4: If any clause, sentence, paragraph, section, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, or part of this local law or in its application to the person, individual, firm or corporation, or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

Section 5: Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

LOCAL LAW TO UPDATE TOWN ZONING CODE

Supr. Marshall said that a Public Hearing can be scheduled for the new zoning code, March 13th.

On a motion made by Councilman Cowley and seconded by Councilman Wohlschlegel the action was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

(No resolution received from town attorney.)

Supr. Marshall said that on Wednesday of this week there will be Public Forum and the purpose of the meeting is to get public input regarding the updated Short Term Rental Law. There has been a committee formed that will be here that evening and basically we are looking for input. We can report what we have discussed so far. We have had a number of committee meetings; David Bowen of the Planning Board, has been incredibly helpful with the changes. The intent of the meeting is to derive input and the next day the committee will meet to discuss the meeting. Supr. Marshall noted that the Town's Comprehensive Plan may need to be addressed as the emphasis is "Maintaining Rural Character" and how that might pertain to Short Term Rentals.

Supr. Marshall said the proposal from SG Security for a security upgrade is more than the Town needs, the proposal calls for 4 pull-down alarms for fire and alarms in the basement.

Councilman Wohlschlegel did speak with SG Security about the proposal and noted that the Town Hall has 3 furnaces in the basement and no fire detection at all down there. Technology wise, the system is old and they don't have replacement parts for it, nothing is wrong with the system now.

Supr. Marshall said the Town needs to get another quote.

Clerk Voss asked if the Town Hall is getting a new phone system? Supr. Marshall agreed, the new system is voice over internet system.

VIII. REPORTS: ASSESSOR

No report.

CEO

Councilman Cowley read the CEO Report.

On a motion made by Councilman Strickland and seconded by Councilman Cowley, the December 2022 CEO Report was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

Supr. Marshall noted that the CEO Office did send a Notice to Remedy, Notice of Violation for the property in Woodville and fully expecting to go to court.

Councilwoman Goodwin asked about the status of the condemned house on Route 64. Supr. Marshall said the last he was told, should we be in Executive Session to discuss. Clerk Voss agreed.

Councilman Cowley said the CEO report states they are still working on issues at 5804 St Rt 64. No details.

Clerk Voss noted that Mr. Pool is back in the hospital, didn't last a week.

Councilman Strickland said we are going to have to do something.

Councilwoman Goodwin asked, what do we do?

Supr. Marshall said the Board should go into Executive Session to discuss.

TOWN CLERK/TAX COLLECTION

IX. ACCOUNTING: SUPERVISOR'S REPORT

Supr. Marshall reported that the bank account has \$3,476,891.00 as of January 31, 2023. in the bank. Revenues of \$66,000.00. Typically, the budget is expended at 10.66% for the General Fund, the Highway Fund is expended at 5.3%.

On a motion made by Councilman Wohlschlegel and seconded by Councilman Cowley, the Supervisor's Report for January 2023 was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

APPROVAL OF VOUCHERS

Supr. Marshall noted that the Fire Departments are being paid this month. Councilman Cowley noted that the total Fire Department amount is \$231,000.00. On a motion made by Councilman Wohlschlegel and seconded by Councilman Strickland, Abstract of Vouchers, totaling \$335,776.48 was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

EXECUTIVE SESSION

On a motion made by Councilwoman Goodwin and seconded by Councilman Strickland, the Board moved into Executive Session to discuss legal matters. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Goodwin, Wohlschlegel, Strickland and Cowley.

The Town Board moved into Executive Session at 7:35p.m.

The Town Board came out of Executive Session at 8:00 p.m. with no action.
