#### **IV. PRIVILEGE OF THE FLOOR**

Joe Kohler of Bristol Harbour, thank you Mr. Supervisor and good evening Town Board, Town Clerk, Highway Superintendent. I first wish to thank again the Highway Department of the Town of South Bristol for keeping your word about a year ago with the paving of Seneca Point Road. Thank you. We appreciate it and all the great work with the plowing and keeping these roads safe in a very challenging township. I guess we have a little bit of dichotomy of wishes in weather in the room. Happy Holidays. A number of weeks ago with your open door policy, which I appreciate, in your office on Saturdays and you've made available these many years. Quite a number of weeks ago you asked me three times, you said, I know what you said because I wrote it down, Mr. Supervisor, you said "what is it you would like the Town of South Bristol to do? What is it?" And I said, "well, thank you for the question. I appreciate the question, respect it but I would like some time to think about that." So I had some time, and I didn't just think about it, I spoke to many residents of the Town of South Bristol, of Ontario County. Of State Officials, of people that have worked for the Town, I met with fire officials from the various fire departments, including Bristol, Cheshire, Wayland, Naples. Residents of Bristol Harbor Village, people down in Woodville and Law Enforcement and we will just leave it at that. There are four things I would like to see from the Town of South Bristol. I present

these to you, I will present these two you on formal stationary as the Coalition of Concerned Citizens, as the founder and the chairman.

- 1. We would appreciate it and would ask the Town to do what ever they can within their power, jurisdiction, moral persuasion or any other way to get the fire hydrants at Bristol Harbor Village unlocked with the legal ring around it and to make them available to the responding fire departments. I would have a comment on that, is not a request: but in my discussions, I understand that there has been some discussions, instead of pulling up from down below, of using the water tower, the water facility, to feed the hydrants with gravity. And that is from the big water tank over there. Now the water company, as we know is privately owned, but the water rates and everything is determined by Albany by the Public Service Commission, who has been very favorable and has put in a lot of time and work and I have been to Albany several times to meet with the PFC at the Secretary's level and with the General Counsel's level. So perhaps the Town, in its capacity might receive some assistance from the Public Service Commission with regards to they hydrants. As we know, or if you don't know, a house burned to the ground on Andrews Way, a cat was inside and the cat was incinerated and I believe the resident, who lives in a wheelchair, fortunately wasn't there. So that is #1 of the 4 items.
- 2. As the BHVA Legal Committee Chair, presented to you several meetings ago and as I had presented to you having had you listen to opinion from our Buffalo/Rochester council, the Rupp Pfalzgraf firm, simply stated that the map that is on file with Ontario County needs correction. You indicated at that meeting you were going to meet with Mrs. Cushing, Mr. Supervisor and I asked you, "Did you meet with Gina?" and I believe you said No, but whether you did or didn't, we would like to see that map corrected.
- 3. I have met with certain Code Enforcement Officers throughout the County, some, I am not going to say who, what, when or where, but we would, not just we at Bristol Harbor, but the people down in the hamlet of Woodville, we would like to see the Code that is on the books here in the Town of South Bristol, enforced as with regards to everything at the marina. From the walls, to the caving walls down into our lockers, to the sewage that was flowing out as witnessed by the community back on the 4th of July from the bathrooms, down on the beach, everything. In Woodville, we would like to see it cleaned up. Not glacial progress, not we are working on it, because as we've all agreed, I think we've all agreed, Mr. Supervisor, tourism is everyone's business in the Town of South Bristol and in the Finger Lakes and in the State of New York.
- 4. I have filed certain FOIL requests I thank the Clerk in assisting me in filling out those FOIL requests, completing them. I have had no response to those requests and it has been over 90-days. The FOIL requests are simple as stated as to what it is I am looking for but I will say it again. I wanted to see everything and everything that I spoke from, this Privilege of the Floor regarding anything. And those are the four items, I will get to you in a signed document on my company station.

On a positive note, regarding property values in the Town of South Bristol, Ontario County in the Finger Lakes, Spectrum News featured this morning a Buffalo State Professor who has been studying weather here in this area for about 45 years, and he concludes that this area is very unique with all that is happening in the world and other parts of the world with horrible

wildfires, earthquakes, tornados, tidal waves, tsunami's as I have lived with and many parts of the world being devastated by that these Finger Lakes and this particular area seems to be one of the best places you might want to live, invest, or visit because of the lack of these horrible, horrible climate change related events that are happening. I thank you and wish you a Happy New Year.

Mr. Kohler thanked Councilwoman Goodwin for her service and all her work. I know how hard you fought for the people of Bristol Harbor and for the Town.

# V. COMMITTEE REPORTS:

# HIGHWAY

Councilman Cowley read the Highway Report for November 2023. Not a whole lot to report on this time of year.

- Trucks are all set up with plows and ready to go.
- Ordered 750 tons of salt.
- Replacing some lights on the salt barn.
- Everyone completed their yearly training at the Town Hall. Thank you, Diane.
- All summer equipment winterized and put in storage.

Supr. Marshall mentioned that the abstract includes a bill for \$28,000.00 for road salt. Supr. Marshall asked if the Highway Superintendent's Association has discussed changing the scraper blades on the trucks to a new material that conforms to the road?

Supt. Wight answered, yes, it is called ReHab React Plate and we have one truck outfitted with this scraper blade. The Association is looking at different grants available and different ways to finance those blades, help the town get them in place. The blades, supposedly, they clean that much better, cut salt usage by a third. This will be on the truck that plows Gulick Road.

Supr. Marshall said that this type of scraper blade on a gravel road is much better.

Supt. Wight agreed, also works well on roads with deep ruts; individual segments of the plow drop down and clean the road better and conform to the roadbed.

Supt. Wight said he looked into the truck purchase we spoke about at the last meeting. There is a truck, on the ground at VanBortel in Victor, that we can have now, and will be a savings of \$5,000.00; the truck is silver, not blue.

On a motion made by Councilman Strickland and seconded by Councilman Cowley, the November Highway Report was ACCEPTED. Voting AYE: 5. Voting NAY: 0. Voting AYE: Marshall, Wohlschlegel, Goodwin, Strickland and Cowley.

Both of the properties identified in 9 and 10 above, presently designated to be in the NC – Neighborhood Commercial District, are rezoned so as to be designated "Government Lands".

The property identified in 11 above, presently designated to be in the C-1 – Light Commercial District, is rezoned so as to be designated "Government Lands".

The property identified in 12 above, presently designated to be in the C-2 –Commercial District, is rezoned so as to be designated "Government Lands".

The property identified in 13 above, presently designated as "Government Lands", is rezoned so as to be designated to be in the C-2 –Commercial District.

Section 1. The opening paragraph of §153-6 of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby repealed and a new opening paragraph of §153-6 is inserted in its place to read as follows:

Pursuant to § 467 of the New York State Real Property Tax Law, real property owned by one or more persons, each of whom is 65 years of age or over, or real property owned by a married couple, one of whom is 65 years of age or over, shall be exempt from Town of South Bristol taxes to the extent shown below of the assessed valuation thereof as determined by the owner's or owners' corresponding annual income:

Section 2. Paragraph A of §153-7 of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby repealed and a new paragraph A is inserted in its place to read as follows:

A. If the income of the owner or the combined income of the owners of the property for the income tax year ("income tax year" shall have the meaning ascribed to it in § 467 of the New York State Real Property Tax Law) is equal to or exceeds the Annual Income amount set forth in §153-6 hereof showing a 0% Reduction. Where title is vested in a married person, the combined income of such person and such person's spouse may not exceed such sum.

Section 3. §153-9 of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby amended with the insertion of a new paragraph C to read as follows:

C. In this Article, the term "income" shall have the meaning ascribed to it in § 467 of the New York State Real Property Tax Law and shall include distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income.

Section 3. Article V (Exemption for Disabled Persons With Limited Incomes) of Chapter 153 (Taxation) of the Code of the Town of South Bristol is hereby amended with the insertion of a new \$153-16 to read as follows:

§ 153-16 Definitions.

In this Article, the term "income" shall have the meaning ascribed to it in § 459-c of the New York State Real Property Tax Law and shall include distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income.

SECTION 4. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.
